2. An environmental safety management plan shall be established, one that is related to the environmental

regular safety education/training shall be conducted and environmental performance shall be assessed.

3. An environmental management system shall be established and implemented. This system shall understand

and employ various environmental laws related to the environmental aspect regarding harmful substances and

pollutants related to corporate management environmental law.

4. An environmental pollution prevention and management system plan shall be practiced. This plan shall

include/promote the use of eco-friendly products, the efficiency of resources and waste recycling through

management and production of its products (considering facilities, etc.) of the Company.

5. The Company shall respond to the easement of climate change by implementing energy-saving practices

and environmental aspects (such as concerns regarding water quality, atmosphere, waste, soil, etc.) to prevent

environment pollution that occurs during corporate activities within business premises.

6. The environmental risk shall be efficiently managed by implementing an environmental impact assessment

and establishing, executing, and revising improvement plans to prevent environment pollution and reduce

pollutants.
